Policies or transfers

Act 2127/1993, Excise tax rates for petroleum products.

Act 2960/2001, Articles 73, 75 and 78. This Law is the Greek Customs Code and provides detailed excise tax rates on the use of petroleum products.

Act 3828/2010, Article 1. (February 2010). Article 1 of this Law amends article 73, paragraph 1 of Law 2960/2001, increasing significantly excise tax rates.

Act 3833/2010, Article 15. (March 2010 – Measures to combat the economic crisis). Article 15 of this Law amends further paragraph 1, article 73 and article 109 of Act 2690/2001, increasing further excise tax rates.
