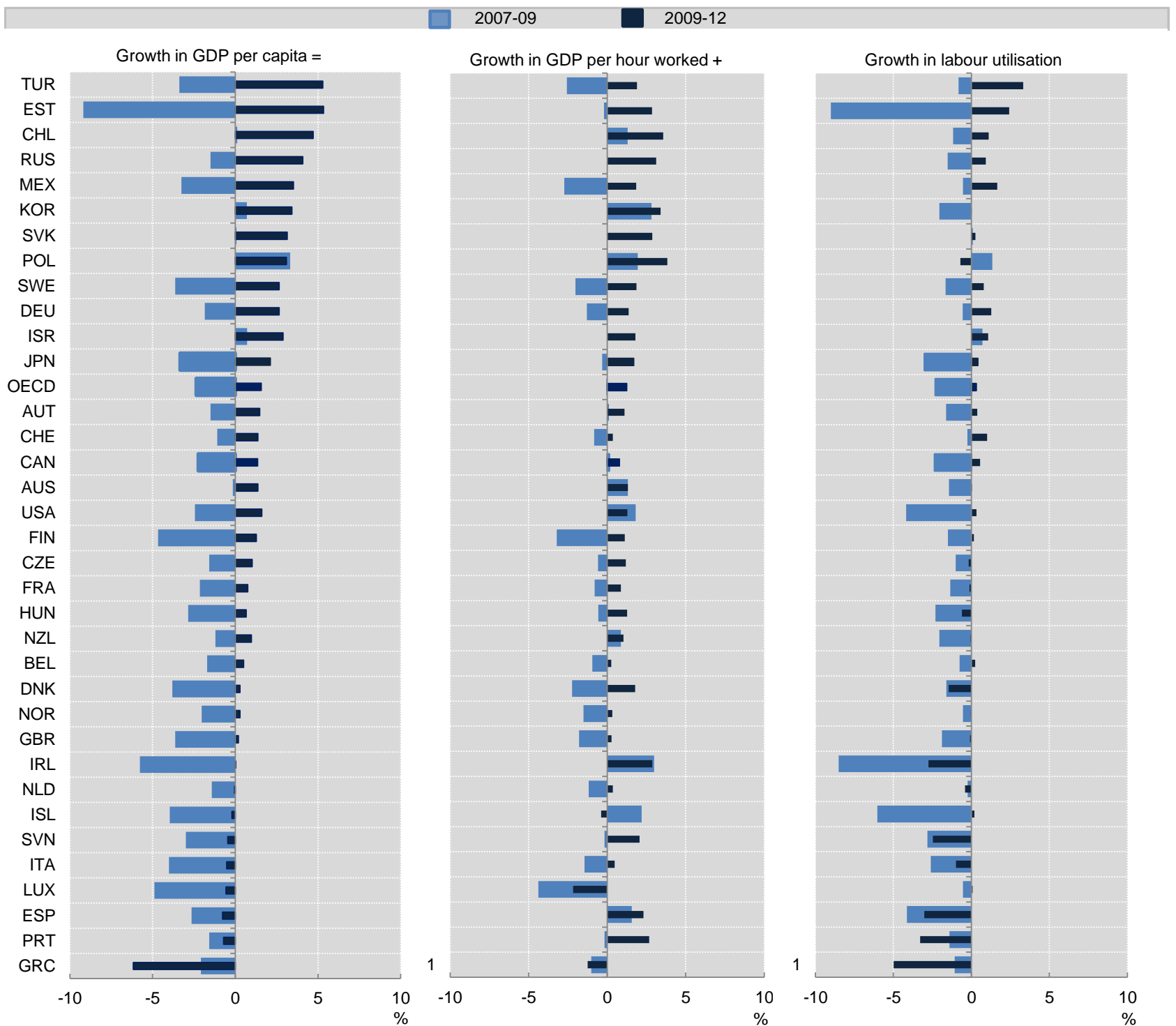


Decomposition of growth in GDP per capita, 2007-09 and 2009-12
